Title: To Approve the Public Arts Commission's Recommendation of Artists to Paint the Ocotillo Park Benches.

RECOMMENDATION:

To approve the Public Arts Commission's recommendation of artists to paint the Ocotillo Park Benches.

BACKGROUND:

The Public Arts Commission has been working on a public art project proposal to have the twenty-three concrete benches at Ocotillo Park painted by artists. Each artist would be compensated \$500 if selected for their original artistic concept to be applied to one of the park's benches. Ocotillo Park is a vibrant park, centrally located in the city that provides a range of recreational activities including ball fields, a basketball court, skateboard park, tennis court, tot lot, splash pad, and shade structures and barbecue stands to encourage group gatherings. The Commission desires to enhance the park by adding a new artistic element throughout the park facility. It also furthers the Commission's goal of making art publicly accessible throughout the city, not only in the downtown area.

At the April 24, 2024 City Council meeting, staff presented the Public Arts Commission's recommendation to approve a \$16,500 budget from the Art in Public Places Fund for the Ocotillo Bench Project, which included:

- \$11,500 for artist stipends (23 @ \$500 each)
- \$4,150 for priming and top-coat of benches
- \$500 for incidental expenditures related to the project.

The City Council approved the item and a call for artists went out soliciting artists to paint the benches

DISCUSSION:

As a result of the call for artists, fifty-two submittals were received representing artists from around the city and region. On June 25, 2024, the Public Arts Commission held a special meeting in which they reviewed all of the artist submittals and selected twenty-three artists

to paint the benches. Two alternates were also chosen in case any of the other artists dropped out. The Commissioners had a daunting task to narrow the field due to the high quality of the submissions received and were diligent in reviewing the art, considering its relevance to the park and the community, its composition, and the overall curation of how all of the painted benches will fit in the park.

The Public Arts Commission selected the following artists twenty-three artists (and two alternates) and are recommending them to the City Council for approval tonight. The bench number corresponds to the location of the bench in the park that they have been selected to paint. The recommended artists are:
