

**NOTICE OF PUBLIC HEARING  
Solid Waste Collection Rates**

IN ACCORDANCE WITH SECTION 6(A) OF ARTICLE XIID OF THE CALIFORNIA CONSTITUTION (PROPOSITION 218) AND GOVERNMENT CODE SECTION 53755 NOTICE IS HEREBY GIVEN that a public hearing will be held before the City Council on **May 28, 2025**, at 5:30 p.m., at 68-700 Avenida Lalo Guerrero, Cathedral City, CA 92234. At the public hearing, the Council will consider the adoption of a resolution to set the maximum rates for solid waste collection and handling under the Franchise Agreement between City of Cathedral City (the "City") and Burrtec Waste and Recycling Services, LLC ("Burrtec") for Integrated Solid Waste Management Services dated July 1, 2010 (the "Franchise Agreement"). The amount Burrtec charges pursuant to the Franchise Agreement includes rates for its services, the City's program costs for providing the service and specified fees charged by the city as authorized under the Integrated Waste Management Act (Collectively "Rates and Fees"). The rates and fees have been determined to be the amount necessary to provide their services and are not more than the reasonable cost to provide the service. The Franchise Agreement authorizes adjustments to the rates and fees based on cost increases associated with collection, disposal, and recycling of solid waste and adjustment to fees based on the annual increase in the consumer price index. The proposed rate increases are designed to ensure that the revenue collected from the solid waste rates is sufficient to cover the full costs of providing solid waste services.

The proposed schedule of maximum permissible service rates is set forth in Exhibit A attached hereto. This rate adjustment is in accordance with the contractually required rate adjustments as set forth in the Franchise Agreement.

- **Rates for Residential Tax Roll Service will become effective January 1, 2026.**
- **Rates for Non-Tax Roll Residential and Commercial Services will become effective July 1, 2025.**

**Proposition 218**

Owners and tenants may respond to the proposed rates **in writing** prior to or during the public hearing. Consistent with the provisions of Proposition 218 and Government Code Section 53755, this notice has been mailed to the record owners of the property at the addresses as they appear on the latest equalized assessment roll. If you object to the proposed rates described in this Notice you may file a written protest with the city at or before the time set for the public hearing. Protests can be mailed or personally delivered to:

Protests will not be accepted by email or facsimile. A valid protest **must** include:

1. The name of the person submitting the protest and their interest in the property (e.g., owner or tenant), and
2. Identification of the property by either assessor's parcel number or street address, and
3. A statement of protest ("I/we protest" will suffice), and
4. The original signature of the protesting owner or tenant (photocopies will not be accepted).

Please note that pursuant to Government Code section 53755(b) only one written protest will be counted per parcel. Multiple protests returned for a single property will be disallowed and the City Clerk will only accept one protest per property.

The City Clerk will determine the validity of all protests submitted and exclude any invalid protests from the final tabulation. The City Clerk may confer with the City Attorney in determining the validity of written protests. As part of this process, the City Attorney may view contested or suspect protest forms. The City Clerk's decision shall be final and binding.

Cathedral City Burrtec Waste and Recycling Services LLC

Single Family Residence Rate Adjustments Effective January 1, 2026, for Tax Roll  
Commercial & Industrial Rate Adjustment Effective July 1, 2025

**Residential Rates**

Residents of Cathedral City pay for their solid waste and recycling collection service through their property tax bill and is based on a calendar year from January 1<sup>st</sup> to December 31<sup>st</sup> of each year.

If approved, the residential tax roll rate for calendar year, January – December 2026, will increase \$1.63 per month or \$19.56 annually.

**Commercial Rates**

Commercial rates are effective July 1, 2025. Commercial customers receive direct bills from Burrtec for services provided.

Cathedral City provides solid waste and recycling collection services via Franchise Agreement with Burrtec Waste and Recycling Services LLC. Solid waste and recycling service rates compensate Burrtec for the services it provides as well as Burrtec's payment of a Franchise Fee and Environmental Fee to the City. Those Fees compensate the City for its management, administration, and direct provision of solid waste services as well as Burrtec's use of government property.
