Exhibit “A” – Scope of Work

Cathedral City – City-Wide Speed Surveys

Our scope of services is as follows:

1. Review previous city-wide speed survey to determine roadway segments for study. Coordinate with City and review other City documents to determine any additional roadway segments in need of analysis.
2. Conduct radar spot speed surveys and 24-hour ADT counts on up to 75 (assumed) roadway segments within the City that do not qualify as residential or business district 25 mph segments. Speed surveys shall be done during non-peak hours to acquire free-flow speed. ADT counts to be collected near the mid-point of each roadway segment.
3. Obtain collision report and information from the City and CHP Statewide Integrated Traffic Records System (SWITRS) data for the last three years of complete available data.
4. Calculate average collision rate per million vehicle miles of travel for each roadway segment.
5. Prepare Engineering and Traffic Survey Sheets that will illustrate the results of a thorough evaluation of the available data and indicate a recommended speed limit for each street segment surveyed.
6. Provide explanation and reasoning for roadway segments that are recommended for new or different posted speed limits.
7. Review land use and roadway features/geometrics for potential inclusion for AB43 analysis to further reduce speed limits.
8. Prepare Speed Survey Evaluation Report in compliance with the California Vehicle Code and California MUTCD.
9. Submit Report to City for review and approval.

This scope does not include the preparation of exhibits, maps, charts, or graphs outside of the speed survey data reports. This scope does not include services not specifically stated in the above scope of work. If additional tasks are desired, a separate scope and budget will be prepared for review and approval prior to the start of additional work.

Exhibit “B” – Compensation

Services described in our Scope of Work (Exhibit “A”) shall be provided on a time and material basis not to exceed **\$45,012**.
